Included-Cancel for Any Reason Waiver Benefit

This additional benefit allows you to cancel your vacation up to 24 hours (or the prior business day, whichever is farther out) before your scheduled departure for any reason. Under this Cancel for Any Reason Waiver Benefit, Globus family of brands will reimburse the cancellation penalty amount in travel certificates, minus the plan cost. Independently arranged air or Instant Purchase Air arranged through the Globus family of brands is not covered.

Any benefit payable under this Travel Protection Plus Plan will be reduced by the amount of any cancellation benefits paid or payable by the Globus family of brands Travel Protection Plan or any other insurance plan providing trip cancellation benefits.

Waiver of Pre-Existing Medical Conditions Exclusion

The Pre-Existing Condition Exclusion is waived if payment for this Travel Protection Plan is received by Globus family of brands with your initial/ deposit payment for your trip.

Group Comp/Tour Conductor Benefit — Should any member of your group of 8 or more cancel after final payment, the Globus family of brands will protect the Group Comp/Tour Conductor as calculated at final payment based on named and fully paid passengers. All passengers in the group must have purchased Travel Protection to qualify for this benefit.

Definitions & Details

Travel Protection benefits for Trip Cancellation (including the Cancel for Any Reason Waiver Benefit), Trip Interruption, Occupancy Upgrade, Missed Connection, and Travel Delay (collectively known as Part A*) are provided by Globus. Cancel for Any Reason Waiver is not an insurance benefit and must be purchased with the initial payment for your trip.

*For New York residents only: 1) Part A benefits are insurance benefits underwritten by United States Fire Insurance Company; 2) The Cancel for Any Reason Waiver Benefit may be purchased separately without purchase of Travel Protection.

Trip Cancellation: Should you cancel your Globus vacation due to a covered injury, sickness, or death—your own or that of a traveling companion or family member—or for other covered reasons as defined, you (in the case of your death, your estate) will be reimbursed up to the trip cost for cancellation charges imposed by Globus and/or by any airline (if booked to provide direct flight connections to join your Globus vacation), if you cancel prior to departure.

See Cancel for Any Reason Waiver Benefit section above for details.

Trip Interruption: Should you interrupt your Globus vacation due to a covered injury, sickness, or death—your own or that of a traveling companion or family member—or for other covered reasons as defined, you (in the case of your death, your estate) will be reimbursed up to 150% of the trip cost for the unused non-refundable land or water travel arrangements of your Globus trip and the additional transportation cost paid to return home or to rejoin your original Globus trip (limited to the cost of economy one-way airfare by scheduled carrier) if you must interrupt your trip after departure.

Occupancy Upgrade: Should your traveling companion or a family member traveling with you cancel or interrupt a Globus vacation due to a covered injury, sickness, death, or for other covered reasons, you will be reimbursed up to your trip cost for Globus charges to change your hotel or stateroom accommodation from twin to single occupancy (or from triple to twin).

Missed Connection: If you miss your cruise or tour departure because your arrival at your trip destination is delayed for 3 hours or more due to a certified delay of a common carrier, inclement weather, unannounced strike, natural disaster, or terrorism, you will be reimbursed up to \$1,000 for the cost of your unused land or cruise arrangements, and the extra airfare paid to join your Globus vacation.

Travel Delay: Covers up to \$150 per day to a maximum of \$1,000 for reasonable additional expenses for hotel accommodation, meal, and local transportation expenses until travel becomes possible if you are delayed 12 hours or more due to a covered reason such as: any delay of a common carrier, quarantine, lost or stolen passports or travel documents, or natural

disaster. Travel Protection benefits for Accidental Death & Dismemberment, Medical Expense/Emergency Medical Assistance (including Accident & Sickness Medical Expense, Emergency Dental Expense, and Emergency Medical Evacuation & Repatriation), One Call 24-Hour Assistance Service, Baggage & Personal Effects, and Baggage Delay (collectively known as Part B) are underwritten by United States Fire Insurance Company.

Accidental Death & Dismemberment: These benefits are paid should a loss occur within 180 days of a covered injury that takes place while on your Globus trip. The maximum benefit while in flight is \$100,000; if other than Air Flight, it is \$25,000.

Accident & Sickness Medical Expense: Only covered expenses incurred within the 60 days following the date of the sickness or injury will be reimbursed. Expenses incurred after the 60 days following the date of the sickness or injury are not covered.

Emergency Dental Expense: Covers the cost of emergency dental treatment received during your Globus trip resulting from a covered injury.

Emergency Medical Evacuation & Repatriation: Covers emergency transport to the nearest adequate medical facility and/or home, when deemed necessary by an attending physician or, in the event of death, the transportation expenses for homeward carriage.

One Call 24-Hour Assistance Service: 24-hour hotline to make emergency travel changes, such as rebooking flights, hotel reservations, tracking lost luggage, and more!

- Advancement of funds to cover emergency medical expenses on your trip
- Telephone interpretation in major languages
- Assistance with replacement of travel documents
- Help in locating local doctors, dentists, or medical facilities
- Relay of e-mail or phone message to family, friends, or business associates

Pre-Trip Travel Advice: Around-the-clock access to passport, visa, inoculation and vaccine requirements, travel advisories, embassy and consulate contacts, travel health advisories, weather and currency information—all for your planned destination.

Baggage & Personal Effects: Coverage for loss or damage to your baggage and personal effects while on your Globus trip. Certain items such as: jewelry, watches, cameras and camera equipment, and furs are subject to a maximum limit of \$600.

Baggage Delay: If while on your Globus trip your checked baggage is delayed for more than 24 hours, you will be reimbursed up to \$250 for the cost of reasonable additional clothing and personal articles purchased during the delay.

Certain exclusions and limitations apply and are detailed in the Description of Coverage available online at TripMate.com/wpF372G or by request from our Travel Consultants. For example, coverage does not apply to: any sickness or condition of you, a traveling companion, family member or business partner traveling with you that existed during the 60 days prior to the effective date of the coverages (this exclusion is waived if your premium is received with your initial deposit/payment for your trip), suicide, normal pregnancy, war or any act of war. A traveling companion is defined as a person with whom you have coordinated travel arrangements and intend to travel with during the trip.

Other covered reasons, as defined, includes the following events or their consequences: cancellation or interruption of your trip due to inclement weather, unannounced strike, or mechanical breakdown that causes complete cessation of services of your common carrier for at least 12 consecutive hours; a documented traffic accident while en route to departure; being hijacked or quarantined; jury duty; destruction of your home or destination by fire, flood, burglary, or natural disaster; being called to the emergency service of government to provide aid or relief in the event of a natural disaster; a documented theft of passports or visas; a transfer of employment of 250 miles or more; involuntary job termination (must be employed with same employer for 1 year); or revocation of military leave due to war.

Payment for the plan is required at time of purchase and is non-refundable once purchased. Prices and coverage are subject to change.
