Included-Cancel for Any Reason Waiver Benefit

Any benefit payable under this Travel Protection Plan will be reduced by the amount of any cancellation benefits paid or payable by the Globus family of brands Travel Protection Plan or any other insurance plan providing trip cancellation benefits.

Waiver of Pre-Existing Medical Conditions Exclusion

The Pre-Existing Condition Exclusion is waived if payment for this Travel Protection Plan is received by Globus family of brands with your initial/deposit payment for your trip.

Definitions & Details

Travel Protection benefits for Trip Cancellation (including Cancel for Any Reason Waiver Benefit), Trip Interruption, Occupancy Upgrade, Delayed Arrival & Missed Connection, and Travel Delay (collectively known as Part A*) are provided by Globus family of brands

*For New York residents only: 1) Part A Benefits are insurance benefits underwritten by United States Fire Insurance Company; 2) The Cancel for Any Reason Waiver Benefit may be purchased separately without purchase of Travel Protection.

Trip Cancellation: Should you cancel your Globus family of brands vacation due to a covered injury, sickness, or death—your own or that of a traveling companion or a family member—or for other covered reasons as defined, you (in the case of your death, your estate) will be reimbursed up to the trip cost for cancellation charges imposed by Globus family of brands and/or by any airline (if booked to provide direct flight connections to join your Globus family of brands vacation), if you cancel prior to departure.

See Cancel for Any Reason Waiver Benefit section above for additional details.

Trip Interruption: Should you interrupt your Globus family of brands vacation due to a covered injury, sickness, or death-your own or that of a traveling companion or a family memberor for other covered reasons as defined, you (in the case of your death, your estate) will be reimbursed up to 150% of the trip cost for the unused non-refundable land or water travel arrangements of your Globus family of brands trip and the additional transportation cost paid to return home or to rejoin your original Globus family of brands trip (limited to the cost of economy one-way airfare by scheduled carrier) if you must interrupt your trip after departure.

Occupancy Upgrade: Should your traveling companion or a family member traveling with you cancel or interrupt a Globus family of brands vacation due to a covered injury, sickness, death, or for other covered reasons, you will be reimbursed up to your trip cost for Globus family of brands charges to change your hotel or stateroom accommodation from twin to single occupancy (or from triple to twin).

Delayed Arrival & Missed Connection: If you miss your cruise or tour departure because your arrival at your trip destination is delayed for 3 hours or more due to a certified delay of a common carrier, inclement weather, unannounced strike, natural disaster, or terrorism, you will be reimbursed up to \$1,000 for the cost of your unused land or cruise arrangements, plus the extra airfare paid to join your Globus family of brands vacation.

Travel Delay: Covers up to \$150 per day to a maximum of \$1,000 for reasonable additional expenses, for hotel accommodation, meal, and local transportation expenses until travel becomes possible if you are delayed 12 hours or more due to a covered reason such as: any delay of a common carrier, quarantine, lost or stolen passports or travel documents, or natural disaster.

Travel Protection benefits for Accidental Death & Dismemberment, Medical Expense/ Emergency Medical Assistance (including Accident & Sickness Medical Expense, Emergency Dental Expense, and Emergency Medical Evacuation & Repatriation), One Call 24-Hour Assistance Service, Baggage & Personal Effects, and Baggage Delay (collectively known as Part B) are underwritten by United States Fire Insurance Company.

Accidental Death & Dismemberment: These benefits are paid should a loss occur within 180 days of a covered injury that takes place while on your Globus family of brands trip. The maximum benefit while in flight is \$100,000, in other circumstances it is \$25,000.

Accident & Sickness Medical Expense: Only Covered Expenses incurred within the 60 days following the date of the Sickness or Injury will be reimbursed. Expenses incurred after the 60 days following the date of the Sickness or Injury are not covered.

Emergency Dental Expense: Covers the cost of emergency dental treatment received during your Globus family of brands trip resulting from a covered injury.

Emergency Medical Evacuation & Repatriation: Covers emergency transport to the nearest adequate medical facility and/or home, when deemed necessary by an attending physician or, in the event of death, the transportation expenses for homeward carriage
