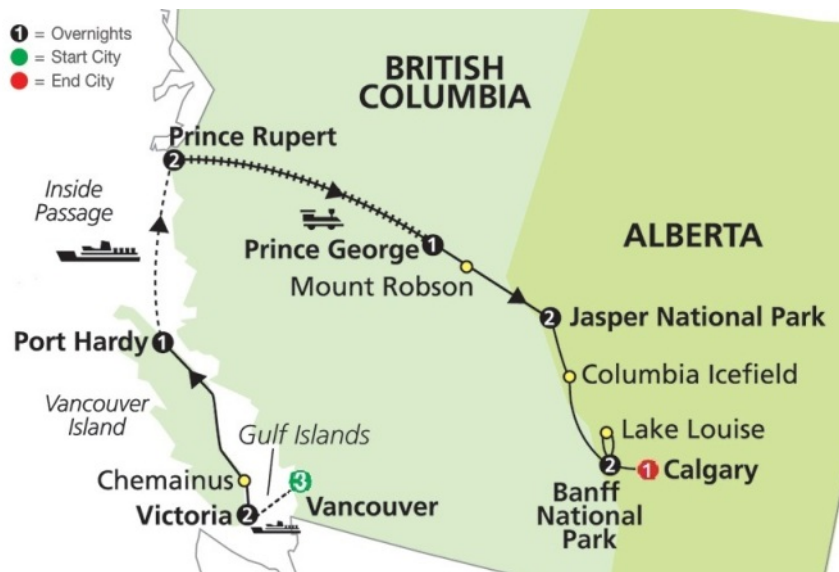

Itinerary

Day 1. Honolulu Departure. Our scenic journey through the Canadian Rockies begins this evening with a departure to the west coast. Once the preliminary flight schedule is ready it will be displayed online.

Day 2. Arrival in Vancouver, British Columbia. After a comfortable flight we touchdown in the morning and make a connecting flight to Vancouver. Upon arrival we are met and transfer to the Century Plaza Hotel, our home for the next three nights. The balance of the afternoon is ours to settle in and start exploring. Alex will be on hand with suggestions.

Day 3. Excursion to Whistler. This morning we take a drive along the scenic *Sea to the Sky Highway*, one of the most beautiful stretches of road in the region. On arrival in vibrant **Whistler** we board the **Peak 2 Peak Gondola**, the longest and highest lift in the world. Savor unparalleled perspective of British Columbia's rooftop - from incomparable views of towering volcanic peaks to coastal rainforest. As we disembark, the experience continues with scenic walking trails, mountaintop restaurants, wildlife viewing, and indoor interpretive displays. Get back to Vancouver in the early evening.

Day 4. Discovering Vancouver. Start the day with a guided city tour highlighting **Stanley Park**, Chinatown, the harbor and beaches, and much more. The rest of the day is at our leisure. Alex and our Tour Director will have suggestions to make the most out of the afternoon. Tonight we savor the sights of Vancouver's waterfront while we dine on a **Sunset Dinner Cruise**. This leisurely cruise takes us past the downtown skyline, Canada Place, the North Shore Mountains, the West Vancouver shoreline and more. (D)

Day 5. Ferry Crossing to Victoria. Set sail across the *Strait of Georgia* through the spectacular **Gulf Islands**, an area known for its Mediterranean-like climate. Upon arrival we enjoy a city tour of Victoria includes Bastion Square and Thunderbird Park with its unusual collection of totem poles. Then make a scenic stop at the famed **Butchart Gardens** to stroll along paths that wind through 50 fragrant acres of blossoms, enchanting theme gardens, streams, and lily ponds! Our next two nights are at the Royal Scot Hotel & Suites.

Day 6. At Leisure in Victoria. Today we have the day to do as we wish. Alex and our Tour Director will have suggestions like the Royal British Columbia Museum, Afternoon Tea at the Empress Hotel, and shopping along Government Street. This evening we explore **Chinatown**, one of the oldest in Canada. Stroll with our expert local who explains to us the ancient cultures like Feng Shui and the Chinese Zodiac. Food sampling along the way with dinner in a first-class restaurant. At dusk we will be given lanterns and lead through the narrow alleys to **Bastion Square**. (D)

Day 7. Via Chemainus to Port Hardy. An early departure from Victoria follows the eastern coastline of **Vancouver Island**, stopping at **Chemainus**, the unique village with more than 30 murals depicting pioneer settlement of the area. Continue via the port of **Campbell River**, the "*Salmon Capital of the World*." Watch for deer, elk and bear along the way. Driving deeper into the great northern forests brings us to remote **Port Hardy**. Port Hardy Inn.

Day 8. Inside Passage Cruise. Early morning embarkation on one of the world's most beautiful ocean voyages. The scenery is spectacular, with towering mountains, roaring waterfalls, endless islands, and virgin rainforest. Marine life abounds, often with sightings of sea lions, eagles, and porpoises - we may even spot a killer whale! Late evening arrival into Prince Rupert. Crest Hotel.

NOTE: Cruising time through the Inside Passage is approximately 16 hours. Please come prepared with all medications, eyeglasses, and any other items you will need.

Day 9. Exploring Prince Rupert. Begin with an orientation tour of **Prince Rupert**, located on Kaien Island. This is the cultural centre of the *Tsimshian*-speaking First Nations people. Next we take a guided tour of the **North Pacific Historic Fishing Village**, a National Historic Site and British Columbia's oldest cannery village. Learn of the canning process and what life was like in the village during peak production in the last century.

Day 10. By VIA Rail's to Prince George. This morning we board **VIA Rail's Jasper - Prince Rupert train** for the trip of a lifetime. Sit back and enjoy an all-daylight journey that winds its way through the majestic **Coast Mountains**, follows the mighty **Skeena River**, often referred to as the "River of Mists," and concludes in the **Pacific Coast rainforest**. Retrace ancient First Nations trading routes and follow the paths of the earliest fur traders. Soaring bald eagles, inquisitive black bears, browsing moose, and other wildlife may be spotted from the glassed-in observation dome that provides 360-degree views. Sandman Hotel Prince George. (CB), (L), (D)

Day 11. Via Mount Robson to Jasper National Park. As our coach continues onward to **Jasper National Park** the peak elevations grow, culminating with **Mount Robson**, the highest of Canada's Rockies at almost 13,000 feet. The evening is free for us to savor the ambiance of this delightful mountain setting. Spend two nights at the Chateau Jasper.

Day 12. Experiencing Jasper National Park. Start the day with a short trip to **Maligne Lake**, a location that epitomizes the Canadian Rockies. Here we enjoy an hour and a half narrated cruise with a brief stop at **Spirit Island** for photos of the magnificent mountains that surround us. Learn of the local history, geology, wildlife, and glaciology of Maligne Lake and of Jasper National Park as some of the most spectacular scenery in the Rockies drift past our windows. In the afternoon we arrive back in Jasper with time visit the quaint shops, take a guided hike, or raft on the Athabasca River.

Day 13. Via the Columbia Icefield and Lake Louise to Banff National Park. Begin a spectacular scenic day as we wind our way down the western fringe of Alberta. Our journey takes us through some of the Canadian Rockies' most breathtaking wilderness. Our first highlight is a stop at the **Columbia Icefield** to experience the **Ice Explorer**, an all-terrain vehicle that travels on 1,200 feet thick ice. Next, magnificent **Lake Louise**, whose cold waters perfectly mirror the surrounding mountains and glaciers. Precipitous gorges, snowcapped mountain ranges, and lakes of exquisite blues and greens come into view as we continue our way south to **Banff National Park**. Enjoy two nights at the Spruce Grove Inn.

Note: Unfavorable weather conditions may affect the availability of the Columbia Icefield Ice Explorer excursion.

Day 14. Banff National Park at Leisure. **Banff** is one of Canada's favorite year-round resorts. The morning is free for us to savor this beautiful town. Perhaps take an optional helicopter ride high over the Canadian Rockies. In the late afternoon we take an eight minute journey to the summit of **Sulphur Mountain** in a modern, fully-enclosed four passenger gondola. The views become increasingly spectacular as we climb 2,292 ft to an elevation of 7,486 ft at the Summit Upper Terminal. Keep an eye out for local wildlife including Rocky Mountain bighorn sheep, Golden mantled ground squirrels, Hoary marmots, Clark's nutcracker and the Canada (Gray) jay. Afterwards, we'll visit thundering **Bow Falls** where plenty of great photo opportunities await.

Day 15. To Calgary. The final leg of our journey takes us to **Calgary**. This cosmopolitan city, steeped in the western cowboy culture, owes its rapid growth to its status as the center of Canada's oil industry. We arrive in the afternoon with a little time to wander before our farewell dinner at the hotel. International Hotel Calgary. (D)

Day 16. To Honolulu. Vivid memories of beautiful scenery and unique modes of transport are with us as we transfer to the airport for our flight home. Our flight makes a quick stop on the west coast before flying to Honolulu.

General Conditions - Western Canada

DEPOSIT AND FINAL PAYMENT: A **\$250** per person *credit card* deposit made directly to the Globus Family is required to secure your space. Please **do not** send money. Once we receive your Reservation Form we will contact you. This deposit is part of your final payment, which is due no later than **65 days** prior to departure. You will receive a final payment request approximately two weeks before its due date. Final payment will be divided, with the land portion going to the Globus Family and the domestic airfare plus any extras going to ES International (DWJ's airline ticketing agent).

Sign-up discounts are combinable with other discounts, but are not transferable to other programs. **Land-only** space is limited. Land price does NOT include airport transfers, dayrooms, or pre or post night hotel accommodations. *These can be purchased.*

CANCELLATION AND REFUND: Full refund* will be made, if cancellation is received up to **120 days** prior to departure; thereafter, only the monies which will be recovered from the hotels, tour operators, airlines, etc., will be refunded. No refund will be made for services not used once the tour commences. All refunds or penalties are subject to the rules and tariffs of the vendors concerned. (*Note: Once your airline ticket is issued it is non-refundable.) There is a \$25 fee for any changes made after 90 days.

TRAVEL INSURANCE: We recommended purchasing travel insurance with your DEPOSIT. This will insure you are covered from a pre-existing condition. We will send you a copy of the coverage offered for this journey. This insurance is refundable up to 120 days prior to departure. You can also purchase insurance with final payment but **will not** be covered for a pre-existing condition.

PRICE: Prices are per person based on two people sharing a room/cabin and accurate as of December 28, 2015. Our journey prices are guaranteed (unless taxes increase). We need a minimum of 14 people to operate this program.

PRICE INCLUDES: The tour price includes airfare (and taxes) based on a special group fare that is subject to certain restrictions; accommodations in Tourist or First Class hotels/trains based on two people sharing a room/cabin with private facilities (bath or shower); meals as indicated in the itinerary: (CB) continental breakfast, (L) lunch, and (D) dinner; and entrance fees where applicable.

NOT INCLUDED: The tour price does not include passport expenses; meals not listed above; all beverages; airport tax; airline baggage fees; baggage and health insurance; laundry expenses; and all items of a purely personal nature. Tips to tour directors, tour drivers, local guides, and hotel personnel; excursions; city sightseeing; and entrance fees are excluded unless specifically noted in the itinerary.

PASSPORT AND DOCUMENTS: A passport, valid 6 months past the date of our return with adequate blank pages, is required.

SINGLE SUPPLEMENT: For persons traveling alone who wish to share hotel rooms, every effort will be made to find you a roommate; however, if this is not possible, through choice or circumstance, the single supplement must be charged.

SIGHTSEEING AND TRANSFERS: All sightseeing and transfers are by private deluxe air-conditioned motorcoach with extra leg room. No Smoking on Cosmos coaches.

BAGGAGE: Due to limited motorcoach capacity, only one suitcase (50 lbs maximum) and one carry-on per person will be allowed. Portage for this suitcase is included in the program's price. Airline baggage fees are not included. No responsibility is accepted for loss of or damage to baggage or any of the passengers' belongings. We strongly recommend buying travel insurance.

RESPONSIBILITY: Dold World Journeys, LLC. and Group Voyagers Inc., dba Globus, 5301 S. Federal Circle, Littleton, CO 80123 (hereinafter referred to as "the Companies") are responsible to you in making arrangements for the tour services offered in the itinerary, including transportation, sightseeing, and hotel accommodations.

The carriers, hotels and other suppliers providing tour services are independent contractors and are not agents, employees, or servants of, or joint ventures with, the Companies or its affiliates. All certificates and other travel documents for tour services issued by the Companies are subject to the terms and conditions specified by the supplier and to the laws of the countries in which the services are supplied. If, after tour departure, the services included in the tour cannot be supplied or there are changes in an itinerary for reasons beyond the control of the Companies, the Companies will arrange for the provision of comparable services. Any resulting additional expense will be payable by tour participants and any resulting savings will be refunded by the Companies to tour participants.

The Companies reserves the right to accept or reject any person as a tour participant, to expel any tour participant from the tour, to make changes in the itinerary whenever the Companies deems it necessary for the comfort, convenience, or safety of the tour participants, and to cancel a tour at any time.

Any disability requiring special attention should be reported to Globus at the time the reservation is made. Globus will make reasonable attempts to accommodate the special needs of disabled tour participants, but the Companies are not responsible for any denial of services by carriers, hotels, restaurants, and other independent suppliers. The motorcoach company and other carrier employees may not physically lift participants or assist them on or off transportation vehicles. Persons requiring such assistance must be accompanied by a qualified companion.

The tour participant agrees that neither the Companies nor its affiliates shall be liable for any damages, loss (including personal injury, death, and property loss), or expense occasioned by any act or omission of any supplier providing tour services or of any other person.

Legal proceedings against the Companies may be instituted only in a state or federal court located within the State of Colorado, and any claim involved in such proceedings shall be decided in accordance with the laws of the State of Colorado. Any legal proceedings against the Companies must be commenced within one year following the date of tour completion.
